Josephine Ghodsee	Water Utilities	\$ 25	Ms. Ghodsee is an Intermediate Typist in the Administrative Services Section. She suggested that a directional sign be installed above the Water Utilities Services counter. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Louis W. Bahr	Park & Recreation	\$ 20	Mr. Bahr is a Utility Worker in the Central Division. He suggested that information be distributed to employees regarding treatment for on-the-job injuries. Although savings were difficult to identify, this was considered to be a significant safety improvement.
Ronald A. Graham	General Services	\$ 20	Mr. Graham is a Sanitation Supervisor in the Solid Waste Division. He suggested the revision of the notice used to inform residents of the street slurry seal schedule. Although savings were difficult to calculate, this was considered to be a significant public service improvement.
Donald L. Bogotay	Park & Recreation	\$ 20	Mr. Bogotay is a Lifeguard II in the Coastal Division. He suggested that the red curb at Cable Street and Del Monte Avenue be extended to increase visibility. Although savings were difficult to calculate, this was considered to be a significant public safety improvement.
