BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of J. W. INDUSTRIAL CLEANING CORP. is hereby accepted and the City Manager is hereby authorized to execute a contract for COLLECTION AND DISPOSAL OF GREASE AND OIL FROM THE SEDIMENTATION TANKS AT POINT LOMA SEWAGE TREATMENT PLANT as may be required for a period of one (1) year beginning October 1, 1982 through September 30, 1983 at a cost of \$17.00 per hour, terms 3% 10 days with an option to renew contract for an additional one (1) year period at a price increase not to exceed 15% of price in effect at the end of the initial contract year.
