That the acceptance by the City Manager of those easement deeds of H. G. FENTON MATERIAL COMPANY, a corporation, executed in favor of The City of San Diego, bearing date of May 4, 1982, copies of which deeds are on file in the Office of the City Clerk as Documents No. RR- 257094 - 1 and No. RR- 257094 - 2, granting to said City easements for storm drain and public street purposes in portions of Lots 2 and 3 of Block 45, Grantville and Outlots, Map No. 776, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street, and the same is hereby named SAN DIEGO MISSION ROAD.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
