
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the expenditure of a sum not to exceed \$378,817.00 is hereby authorized from CIP 37-055.4 for the sole and exclusive purpose of providing funds necessary to accomplish this relocation work.
