RESOLUTION NUMBER R- 257109

Adopted on SEP 13 1982

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the petition of property owners in the Sabre Springs Community Planning Area for a Landscape and Lighting Assessment District in said area be and is hereby accepted, said petition is on file in the office of the City Clerk as Document No. 768555.

BE IT FURTHER RESOLVED, that the external boundaries of the proposed district shall be Interstate Highway 15 on the west and the established boundaries of the Sabre Springs Community Plan on the south, east, and north sides.

BE IT FURTHER RESOLVED, that the district will be for maintenance and lighting purposes only and the district proposes no construction of facilities at this time.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to initiate proceedings for the formation of said Landscape and Lighting Assessment District pursuant to the Landscape and Lighting Act of 1972 (Sections 22500, et seq., Streets and Highways Code) and the San Diego Maintenance District Procedural Ordinance of 1975 (Sections 65.0201, et seq., San Diego Municipal Code), said district shall be known and designated as the Sabre Springs Landscape and Lighting Maintenance District.

BE IT FURTHER RESOLVED, that the deposits of Two Thousand Dollars (\$2,000) from the Pardee Construction Company into Trust Fund 63021 for the purposes of establishing said district is hereby accepted.
