BE IT RESOLVED, by the Council of The City of San Diego, as follows:



BE IT FURTHER RESOLVED, that the County Board of Supervisors is hereby requested to give direction to its staff to pursue further the University of California San Diego's offer, a copy of which is attached to this resolution, which would appear to provide an opportunity for an excellent and efficient development for the mutual benefit of the two public agencies.

Dear Mr. Graves:

I am writing to inform you, there is some interest on the part of the University of California, San Diego, to explore with the County the use of UCSD land for the location of the Central Mental Health Facility, which the County is planning to build. The interest on behalf of UCSD, emerged from some informal discussions between Chancellor Richard C. Atkinson, the Vice Chancellor for Health Sciences, Robert G. Petersdorf, M.D. and myself. It was our feeling, that the cooperative establishment by the County and University of a high quality and comprehensive central mental health center is a unique and exciting opportunity to do something very positive for the citizens of San Diego who would be served by such a facility. Obviously, if such a facility were located on the campus, the University would be intimately involved in the operation of the clinical program, but in partnership with the County and in a manner which would be mutually acceptable to both parties. The details of the relationship would have to be worked out as a part of the exploration process.

Currently, our interest is high in pursuing this with the County and I would urge you to raise this possibility with the Board of Supervisors as an aspect of the ongoing discussions in regard to the location and the building of the central CMH facility. I'll look forward to hearing from you after you have had the opportunity to bring this issue to the Board. Thank you very much for your attention to this matter.
