A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO CONSENTING TO A JOINT PUBLIC HEARING, AUTHORIZING THE ESTABLISHMENT OF A DATE, TIME AND PLACE THEREFOR, AND AUTHORIZING PUBLICATION AND MAILING OF NOTICE OF JOINT PUBLIC HEARING ON THE PROPOSED REDEVELOPMENT PLAN FOR THE MOUNT HOPE REDEVELOPMENT PROJECT.

WHEREAS, the California Community Redevelopment Law (Health and Safety Code Section 33355) authorizes a joint public hearing on the proposed Redevelopment Plan for the Mount Hope Redevelopment Project, with the consent of the Redevelopment Agency of The City of San Diego (the "Agency") and the City Council of The City of San Diego; and

WHEREAS, the Agency by resolution has consented to a joint public hearing on the proposed Redevelopment Plan for said Project and has requested that the City Council consent to such joint public hearing and establish the date, time and place therefor; NOW, THEREFORE,


BE IT RESOLVED, by the City Council of The City of San Diego, as follows:

1. The City Council hereby consents to a joint public hearing on the proposed Redevelopment Plan for the Mount Hope Redevelopment Project and hereby authorizes the Executive Director of the Agency (or his designee) to establish the date, time and place for such joint public hearing.

2. The City Clerk of The City of San Diego shall, in cooperation with the Executive Director of the Agency (or his designee), publish and mail a notice of public hearing on the proposed Redevelopment Plan, in the manner, and with other documents as required and established by law.
