RESOLUTION NUMBER R- 257130

Adopted on SEP 14 1982

WHEREAS, U. S. Senate Bill S.2786 has been introduced in the Congress of the United States; and

WHEREAS, S.2786 would place a moratorium on Outer Continental Shelf (OCS) drilling activities in portions of the Southern California OCS Planning Area extending from the Newport Beach area south to the Mexican Border; and

WHEREAS, such a moratorium would remain in effect until January 1, 2000; and

WHEREAS, the estimated reserves off the coast of San Diego are equivalent to only a 36-hour supply of oil for the country, and therefore of little importance to our national energy supply; and

WHEREAS, the City Council of The City of San Diego passed previous resolutions opposing such oil drilling activities, once in 1979, R-222043, again in 1981, R-254127; and

WHEREAS, S.2786 is consistent with the positions and policies previously adopted by The City of San Diego regarding OCS proposals in the area; and

WHEREAS, S.2786 will be subject to the deliberations of the relevant committees and floor votes in the Senate and Congress of the United States; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City hereby declares its support of S.2786 and directs the Department of Intergovernmental Relations to communicate

this position to appropriate members of Congress and other interested officials as a further expression of its opposition to oil and gas exploration in this sensitive coastline region.
