


RESOLUTION No. R-257137 (R-83-314)Adopted on SEP 14 1982

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$97,850.00 by HYDRO-CLEAR CORPORATION, a corporation, for SAN DIEGO AQUATIC TREATMENT PILOT PROGRAM, EQUIPMENT PROCUREMENT CONTRACT NO. 1, Section IV - Pulsed Bed Filter in the City of San Diego, California, is hereby accepted and the City Manager is hereby authorized to execute a contract therefore in accordance with the specifications on file in the Purchasing Department.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$97,850.00 within the Sewer Revenue Fund No. 41506 from the Unallocated Reserve 70697 to the Wastewater Research Program 70217.
3. That the expenditure, not to exceed \$97,850.00 from Sewer Revenue Fund No. 41506, Wastewater Research Program 70217 of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs.
