BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by WILLIAM GREGORY CLARKE, a Licensed Land Surveyor, entitled "ELDORADO HILLS UNIT NO. 14 Being a subdivision of a portion of Lots 27 and 38 of Rosedale Tract, according to Map thereof No. 825, filed in the office of County Recorder of San Diego County, and a portion of Lot 60, Rancho Mission of San Diego, California, according to the Partition Map thereof made in Superior Court Case No. 348 and filed in the office of County Recorder of San Diego County as Map No. 330, and a portion of Lots "D" and "E," Referee's Partition Map of a portion of Lot 70, Rancho Mission of San Diego, County of San Diego, State of California, together with Colina Dorada Drive and Pendiente Court as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.


