

RESOLUTION NUMBER R-257196

Adopted on September 21, 1982

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Pursuant to authority conferred by and in accordance with the provisions of Section 86.04 of the San Diego Municipal Code, a PARKING TIME LIMIT OF TWO HOURS, between the hours of 8:00 a.m. and 6:00 p.m., Sundays and holidays excepted, be and the same is hereby established on the following street in said City:

The east side of 55th Street from the first alley north of El Cajon Boulevard to a point 50 feet south of the alley.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is hereby authorized to be made on said street, and the regulations hereinabove imposed shall become effective upon the installation of such signs.

BE IT FURTHER RESOLVED, that Resolution No. 207665, adopted on April 3, 1973, which established a two-hour parking time limit on the east side of 55th Street from El Cajon Boulevard to the alley to the north be and is hereby rescinded.
