APPROVING MAP OF THE DELLS UNIT NO. 1

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by ROBERT G. SCHOETTNER, a Licensed Land Surveyor, entitled "THE DELLS UNIT NO. 1 Being a subdivision of Lots 28 through 48 in Block 127 and Lots 1 through 48 in Block 128 of Choates Addition, according to Map thereof No. 167, filed in the office of County Recorder of San Diego County, November 20, 1886, and a portion of Lot 29 and Lots 30 through 38 in Block 1 of McLaren's "H" St. Addition, according to Map thereof No. 291, filed in the office of County Recorder of San Diego County, July 27, 1887, and Fractional Lots 24 and 25, in Block 128 of E. W. Morse's Subdivision of Pueblo Lot 1150, according to Map thereof No. 547, filed in the office of County Recorder of San Diego County, December 30, 1871, and Lots 36 through 48, in Block 128 of Reed and Swayne's Central Park Addition, State of California, according to Map thereof No. 982, filed in the office of County Recorder of San Diego County, March 28, 1906, together with Bancroft Street, lying between Block 1, Map No. 291 and Block 128, Map No. 982, the Alley in Block 128 and "G" Street, all as being closed and vacated to public use, in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the

surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public a portion of 32nd Street and a portion of 33rd Street for public purposes; and said portions of streets are hereby declared to be portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, and that said portions of public streets are accepted on behalf of the public as heretofore stated; and that those easements with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated..

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego.
