BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. GRAYBAR ELECTRIC COMPANY, INC., 2. ATLAS WIRE & CABLE, 3. GENERAL ELECTRIC SUPPLY CO., 4. DARDANELLA ELECTRIC CORP. (DECO), 5. ELECTRIC SUPPLIES DIST. CO., and 6. COUNTY WHOLESALE ELECTRIC are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of ELECTRICAL COMPONENTS, MAINTENANCE MATERIALS, AND FIXTURES as may be required for a period of one (1) year beginning September 1, 1982 through August 31, 1983 per prices on file in the Purchasing Department as follows:

1. GRAYBAR ELECTRIC COMPANY, INC. - for Section I, terms 2% 20 days, plus sales tax, with an option to renew contract for an additional one (1) year period.
2. ATLAS WIRE & CABLE - for Section II, terms 2% 20 days, plus sales tax.
3. GENERAL ELECTRIC SUPPLY CO. - for Section III, terms 2% 30 days, plus sales tax, with an option to renew contract for an additional one (1) year period.
4. DARDANELLA ELECTRIC CORP. (DECO) - for Sections IV and VI, with a potential escalation of 8% during the contract year, terms 2% 20 days, plus sales tax.
5. ELECTRIC SUPPLIES DIST. CO. - for Sections V and VIII, terms 2% 10 days, with an option to renew contract for an additional one (1) year period.
6. COUNTY WHOLESALE ELECTRIC - for Sections VII and IX, terms 2% 25 days, with an option to renew contract for an additional one (1) year period.
