APPROVING MAP OF CAMELOT BY THE BAY.

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by WILLIAM GREGORY CLARKE, a Licensed Land Surveyor, entitled "CAMELOT BY THE BAY Being a subdivision of Lots 17 to 22, inclusive, in Block 52 of Morena, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 542 and 809, filed in the office of the County Recorder of San Diego County, May 22, 1888 and January 3, 1896 respectively, together with portions of Erie Street as vacated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public a portion of Erie Street for public purposes, and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation the easement with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.


