
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a deed conveying to the CITY OF ESCONDIDO, a municipal corporation, an easement for drainage purposes affecting a portion of Rancho San Bernardo, as more particularly described in that deed on file in the office of the City Clerk as Document No. RR- 257214-1.

BE IT FURTHER RESOLVED, that the acceptance by the City Manager of that deed of LAKE HODGES ESTATES DEVELOPMENT COMPANY, executed in favor of The City of San Diego, bearing date of June 21, 1982, conveying to said City an easement for ingress and egress, road, utility, sewer, and domestic water purposes affecting a portion of Lot "A" of Escondido Tract 474, as more particularly described in said deed on file in the office of the City Clerk as Document No. RR- 257214-2.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to cause the deed to The City of San Diego, and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder, and to deliver the deed to the City of Escondido to the Property Department for further handling.
