BE IT RESOLVED, by the Council of The City of San Diego, as follows:



Both sides of Juan Street and a point 180 feet north of Harney Street and a point 295 feet south of Harney Street.

BE IT FURTHER RESOLVED, that Resolution No. 222913 be and is hereby rescinded.

BE IT FURTHER RESOLVED, that the necessary signs and markings be, and the same are hereby authorized to be made on said streets and that the regulations hereinabove imposed shall become effective upon the installation of such signs.
