BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with DEARDORFF & DEARDORFF for professional services for the design and construction of nine (9) beach access stairways and two (2) comfort stations, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 257216, with the proviso that the Camino del la Costa project be delayed to the latest possible date (no later than December 31, 1982) to allow for public review before the Coastal Area Committee of the Park and Recreation Board regarding design of project, and if necessary, before the Public Facilities and Recreation Committee if further public testimony/hearing is necessary.


