

RESOLUTION NO R-257235Adopted on SEP 28 1982

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Richard J. Hunt	Water Utilities	\$5,000	Mr. Hunt is a Principal Engineering Aide in the Utilities Services Division. He suggested that developers be charged a fee for killing the old water service at the water main when the property is redeveloped. This idea has been in use for one year and has generated a revenue increase of \$67,860. In addition, the estimated savings for the first year have been \$50,000 in costs for claims processing and payments, labor costs and water loss. This is the maximum award allowed under the program.
Joyce E. Moe	Library	\$2,655	Ms. Moe was an Intermediate Typist at the time she submitted her suggestion. She suggested that printed Library rules be distributed to Library card applicants. It is estimated that this has saved \$8,844 in the first year in labor costs.
Robert E. Crist	Fire	\$1,575	Mr. Crist is an Auto Messenger. He suggested that the Fire Department purchase reconditioned air bottles rather than new ones. This is expected to save \$5,250 in the first year in equipment costs.
