WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

John R. Crowell	Police	\$ 660	Mr. Crowell is an Evidence Technician in the Administrative Services Division. He suggested that the Ninhydrin solution for detecting latent fingerprints be prepared in-house. This is expected to save \$1,197 in the first year in material costs. In addition, the formula prepared in-house is significantly safer than the commercial formula.
Maria C. Santuario Cristina Z. Cruz	Library	\$ 555	Ms. Santuario and Ms. Cruz are Intermediate Typists. They suggested that a Spanish version of the printed Library rules be provided to Library card applicants. This is expected to save \$1,843 in the first year in labor costs.
Peter O. Solomonsen	Police	\$ 500	Mr. Solomonsen is a Police Officer II in the Administrative Services Division. Approximately one year ago he earned a partial award of \$500 for his suggestion to dictate background investigation reports rather than hand writing them. One year's experience has shown a savings of \$25,267. This is the remainder of his award.
