

RESOLUTION NO. R-257237Adopted on SEP 28 1982

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Gordon B. Russell	General Services	\$355	Mr. Russell is a Communications Technician in the Communications & Electrical Division. He suggested that the Fire Department upgrade its sirens with PA-200 sirens rather than PA-2100 sirens. This is expected to save \$1,178 in the first year in equipment costs.
Wayne L. Ramsey	Treasurer	\$205	Mr. Ramsey was a Supervising Field Representative at the time he submitted his suggestion. One year ago he earned a partial award of \$180 for his suggestion to determine the status of businesses prior to mailing business license renewal cards. One year's experience has shown a savings of \$1,277. This is the remainder of his award.
Daniel Karsh	Police	\$185	Mr. Karsh is a Sergeant in the Traffic Division. One year ago he earned a partial award of \$170 for his suggestion to discontinue sending copies of the Traffic Warrant arrest reports to the Traffic Division. One year's experience has shown a savings of \$1,190. This is the remainder of his award.
Robert N. Edgett	Police	\$145	Mr. Edgett is a Police Officer in the Traffic Division. He suggested that the radar units be secured in the traffic vehicles. This is expected to save \$489 in the first year in labor costs.
