Delorese J. Shafer	Risk Management	\$ 25	Ms. Shafer is an Intermediate Typist. She suggested that mailing labels be used on Management Benefits Plan disclosure statements. This is expected to save \$77 in the first year in labor costs.
Jessiemay Faith	Library	\$ 20	Ms. Faith is an Intermediate Typist. She suggested that a card be used to order free material for the Library. This is expected to save \$41 in the first year in labor and material costs.
Florencia V. Santos	Building Inspection	\$ 20	Ms. Santos is an Intermediate Typist. One year ago she earned a partial award of \$25 for her suggestion to add drawings to the handout illustrating sign permit requirements. One year's experience has shown a savings of \$150. This is the remainder of her award.
