RESOLUTION NUMBER R- 257242

Adopted on SEP 28 1982

WHEREAS, the San Diego Urban League is the current Grantee of a grant from the Economic Development Administration in the amount of \$750,000; and

WHEREAS, in June 1982, the Economic Development Administration advised the Urban League that said grant could only be utilized within the Dells Redevelopment Project Area; and

WHEREAS, the City of San Diego and the Southeast Economic Development Corporation strongly desire that the proposed project go forward within the Dells Redevelopment Project Area; and

WHEREAS, the Economic Development Administration has advised that the grant will be withdrawn at the end of September unless certain conditions are immediately fulfilled; and


WHEREAS, the City and the Southeast Economic Development Corporation believe that with the cooperation of the Urban League said conditions can be met within a reasonable period of time so that the project construction may go forward in accordance with the terms of the grant; NOW, THEREFORE,

BE IT RESOLVED, that The City of San Diego hereby directs the Mayor to communicate with the Secretary of the Economic Development Administration of the U. S. Department of Commerce, and any other appropriate parties, to express the City's strong desire that the Secretary postpone any action to withdraw the

authorized grant for a reasonable period sufficient to enable the San Diego Urban League, the Southeast Economic Development Corporation and The City of San Diego to complete arrangements to fulfill the terms of the grant and preserve this economic opportunity for the welfare of the San Diego community.
