RESOLUTION NUMBER R-257267

Adopted on OCT 4 1982

WHEREAS, H.R. 4929 would establish The Public Employee Pension Plan Reporting and Accountability Act (herein called "PEPPRA"); and

WHEREAS, said H.R. 4929 would impose new reporting, disclosure and fiduciary requirements on public employee pension plans and represent an incursion into and erosion of local control; and

WHEREAS, "PEPPRA" would establish a new level of federal bureaucracy within the Department of Labor which would add significant costs to those affected pension systems; and

WHEREAS, the administration in Washington, D. C. is on record as opposing H.R. 4929 for the above stated reasons; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Council hereby expresses and declares its opposition to H.R. 4929, the Public Employee Pension Plan Reporting and Accountability Act and urges its Congressional representatives to oppose said bill.

BE IT FURTHER RESOVLED, that the City's legislative representative in Washington, D. C. be notified of this action and instructed to act accordingly.
