
BE IT RESOLVED, by the Council of The City of San Diego as follows:

BE IT FURTHER RESOLVED, that the transfer of \$6,509.96 from Trust Fund 63021 to Capital Outlay Revolving Fund 30245/102, and \$2,448 from Trust Fund 63021 to Revolving Fund Resolution No. 251505, 30244/106, Account No. 390001 is hereby authorized.

BE IT FURTHER RESOLVED, that the expenditure in the sum of \$8,957.96 from 63021 Deposit Trust, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
