

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$50,000 from Community Development Block Grant Fund 18516 for acquisition and related expenses for this project is hereby approved and authorized.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver both deeds, and a certified copy of this resolution, attested by him under seal, to the Property Department for further handling.
