
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of UNIVERSITY FORD is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of TWENTY-FIVE (25) COMPACT POLICE SEDANS (1983 Ford Fairmounts with 200 CID V-6 engine) at a cost of \$7,115.56 each for a total cost of \$177,889.00; terms net 20 days, plus sales tax, less trade-in allowance as follows:
