
BE IT RESOLVED, by the Council of The City of San Diego as follows:

WESCO are hereby accepted and the City Manager is hereby authorized to execute contracts for the WILL CALL SERVICE FOR THE PURCHASE OF ELECTRICAL PARTS, SUPPLIES AND EQUIPMENT as may be required for a one (1) year period beginning October 1, 1982 through September 30, 1983, per prices on file in the Purchasing Department as follows:
