BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to execute, for and on behalf of said City, an agreement with the CALIFORNIA DEPARTMENT OF TRANSPORTATION (CALTRANS), transferring bicycle lockers for distribution to other agencies in the San Diego Region, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR- 257346 .
