
Adopted on OCT 25 1982

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those street and drainage easement deeds of SCRIPPS MEMORIAL HOSPITAL, et al, executed in favor of The City of San Diego, copies of which deeds are on file in the Office of the City Clerk as Documents No. RR- 257364-1 and RR- 257364-2, granting to said City easements for public street and drainage purposes in the Northeast Quarter of Section 4, Township 15 South, Range 3 West, S.B.M., as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street, and the same is hereby named LUSK BOULEVARD.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
