That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Woodward-Clyde Consultants for professional engineering services in connection with a dynamic seismic evaluation of Chollas Heights Reservoir Dam, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 257370.

BE IT FURTHER RESOLVED, that the transfer of \$17,500 from General Fund Unallocated Reserve to Nondepartmental Expenditures Special Consulting Services Program for dynamic seismic evaluation of Chollas Heights Reservoir is hereby authorized.

BE IT FURTHER RESOLVED, that the expenditure in the sum of \$80,500 from Nondepartmental Expenditures for dynamic seismic evaluation of Chollas Heights Reservoir Dam, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
