
Adopted on OCT 25 1982

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That Change Order No. 1, filed with the City Clerk of said City as Document No. RR-257376, issued in connection with the contract between The City of San Diego and H. L. Foster Construction Company, for the improvement of Athey Avenue from Vista Terrace Park to Smythe Avenue, said contract having been filed in the office of the City Clerk as Document No. 255030, be and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract price of \$7,833.17.

2. That the expenditure in the sum of \$12,200 from CDBG Fund 18517, Dept. 5988, Org. 8803, to supplement Resolution No. R-255030 adopted September 12, 1981, for contract change orders and project contingencies for the improvement of Athey Avenue from Vista Terrace Park to Smythe Avenue, is hereby authorized, solely and exclusively for the purpose of providing funds for the above program.
