RESOLUTION OF THE CITY COUNCIL AUTHORIZING A
WORKSITE AGREEMENT WITH THE COUNTY OF SAN DIEGO
FOR CITY PARTICIPATION IN THE COUNTY'S WORKFARE
PROGRAMS.

WHEREAS, during the past several years, the County of San Diego has operated "Workfare Programs," wherein Food Stamp and General Relief recipients are required to perform work in various County departments; and

WHEREAS, the City Council previously authorized the City Manager to enter into an agreement with the County of San Diego, wherein City of San Diego worksites would also be utilized; and

WHEREAS, the Workfare Programs are being expanded to include recipients of Aid to Families with Dependent Children; and

WHEREAS, the City wishes to participate in these programs;
NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:
