WHEREAS, fuel efficient traffic signal management by The City of San Diego will provide benefits to the local community in the form of improved traffic flow, reduced fuel consumption, reduced vehicle operating costs, reduced air pollutant emissions, and improved safety due to smoother flow; and

WHEREAS, funds have been established and are available through the California Energy Commission for grants to local governments for efficient traffic signal management projects; NOW, THEREFORE,

BE IT RESOLVED, that the City Council of The City of San Diego, authorizes the submittal of an application to the California Energy Commission for a grant and the City Manager of the City of San Diego is hereby authorized and empowered to submit for and on behalf of The City of San Diego, all necessary applications to carry out the purposes specified in this resolution.
