| Max J. Saska | Water Utilities | \$5,000 | Mr. Saska is a Principal Water Utilities Supervisor in the Systems Division. He suggested that V. C. pipe be installed at Pump Stations 11 and 14 to provide additional sewerage holding capability. The department had originally planned to install fiberglass holding tanks at an estimated cost of \$118,365. The installation of the V.C. pipe saved \$67,679 in labor, material and equipment costs. |
| Donald W. Pio | Park & Recreation | \$2,480 | Mr. Pio is an Equipment Operator in the Central Division. One year ago he earned a partial award of \$1,830 for his suggestion to modify the method of attaching the cutting blades to the lawn renovators. One year's experience has shown a savings of \$12,706. This is the remainder of his award. |
| Thelma Shuker | City Attorney | \$ 550 | Ms. Shuker was a Programmed Typewriter Operator in the Criminal Division at the time she submitted her suggestion. One year ago she earned a partial award of \$530 for her suggestion to use a daily log for all cases run on the Mag Card typewriter. One year's experience has shown a savings of \$3,607. This is the remainder of her award. |
