Paula A. Lundmark	City Auditor	\$ 475	Ms. Lundmark is an Account Clerk in the Capital Projects Division. She suggested that the preparation of Job Order Assignment Sheets be eliminated in her division. This is expected to save \$1,589 in the first year in labor costs.
Kathleen A. Avery	Fire	\$ 415	Ms. Avery was an Intermediate Typist at the time she submitted her suggestion. One year ago she earned a partial award of a Certificate of Merit for her suggestion to increase the fee charged for subpoena records. One year's experience has shown increased revenue of \$1,376. This is the remainder of her award.
Ruth E. Klauer	City Clerk	\$ 315	Ms. Klauer is a Senior Typist. She suggested that the work order number on each specification book be used as the official document number. This is expected to save \$1,055 in the first year in labor costs.
Florencia V. Santos	Building Inspection	\$ 310	Ms. Santos is a Data Entry Operator. She suggested that an unnecessary step in the processing of sign permits be eliminated. This is expected to save \$2,065 in the first year in labor costs. This is a partial award pending a final 12 month review.
