

RESOLUTION NO. R-252392Adopted on OCT 26 1982

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Norval L. Brewer	Fire	\$ 275	Mr. Brewer was a Battalion Chief at the time he submitted his suggestion to replace vehicle belts and hoses on an as-needed basis only. He earned a partial award of \$830 for this idea. One year's experience has shown a savings of \$3,684. This is the remainder of his award.
Eustis Nikas Robert Snowden	General Services	\$ 270	Mr. Nikas and Mr. Snowden were Sanitation Supervisors in the Solid Waste Division at the time of this suggestion. One year ago they earned a partial award of \$65 for their suggestion to use rigid plastic liners in litter containers rather than corrugated liners. One year's experience has shown a savings of \$3,325. This is the remainder of their award.
Barbara Center-Amy	Personnel	\$ 220	Ms. Center-Amy is a Senior Clerk. She suggested that post cards be used to notify applicants of extensions to eligibility lists. This is expected to save \$1,445 in the first year in labor, material and postage costs.
James H. Kline	Fire	\$ 150	Mr. Kline is a Fire Captain. He suggested that damaged vehicle windshields be repaired rather than replaced. This is expected to save \$500 in the first year in new windshield installations.
