George R. Ikeda	General Services	\$ 140	Mr. Ikeda is a Carpenter in the Buildings Division. One year ago he earned a partial award of \$215 for his suggestion to purchase a T-square saw fence. One year's experience has shown a savings of \$1,188. This is the remainder of his award.
Marian J. Avila	Library	\$ 75	Ms. Avila is a Librarian. One year ago she earned a partial award of a Certificate of Merit for her suggestion to print form LI-97 on a less expensive grade paper. One year's experience has shown a savings of \$244. This is the remainder of her award.
Jeanne D. Hammon Linda L. Loveland	Park & Recreation	\$ 50	Ms. Hammon is an Administrative Aide and Ms. Loveland is an Intermediate Typist in the Central Division. They suggested that the locks to the Park & Recreation Department offices be changed to reduce thefts. Although savings were difficult to calculate, this was considered to be a significant public safety improvement.
Mary F. Labiak	Park & Recreation	\$ 30	Ms. Labiak is an Intermediate Typist in the Central Division. One year ago she earned a partial award of \$20 for her suggestion to clearly identify subdivision maps for condominium conversions to distinguish them from new subdivisions. While first year's savings were difficult to calculate, the idea improved communications between two departments and an additional award was recommended.
