| Nicholas J. Lanning | Water Utilities   | \$ 25         | Mr. Lanning is a Storekeeper in the Systems Division.<br>He suggested that the procedure for locating requestors of supplies be simplified. Although savings were difficult to identify, this was considered to be a significant operational improvement.                       |
| John T. Mulvey      | City Clerk        | \$ 25         | Mr. Mulvey is an Intermediate Clerk.<br>He suggested that reference guides be fabricated and installed on the Filemaster machine. This is expected to save \$81 in the first year in labor and material costs.  |
| Jack A. Mead        | Park & Recreation | \$ 25         | Mr. Mead is an Equipment Technician II in the Central Division. He suggested that a simpler and safer method for handling chlorine cylinders be developed. Although savings were difficult to estimate, this was considered to be a significant safety improvement.             |
| William Pontsler    | General Services  | \$ 20         | Mr. Pontsler is an Electrician Supervisor in the Buildings Division. He suggested that non-breakable switch and receptacle plates be installed in City buildings. Although savings were difficult to identify, this was considered to be a significant operational improvement. |
