

1. That the bid of \$19,300.00 by T.G.S. ELECTRIC, INC., dba ARROW ELECTRIC, a corporation for CONSTRUCTION OF VILLA LA JOLLA PARK LIGHTING in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the specifications on file in the office of the City Clerk as Document No. A-00294.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$8,000.00 from Park Service District Fund 11483 to CIP No. 29-463, VILLA LA JOLLA NEIGHBORHOOD PARK AREA LIGHTING.
3. That the expenditure of \$27,500.00 from CIP 29-463, VILLA LA JOLLA NEIGHBORHOOD PARK AREA LIGHTING of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs.
