That Resolution No. R-251763, adopted by this Council on May 5, 1980, be and it is hereby amended by deleting Public Plaza Park and substituting Canyonside Community Park as City designated projects to be funded under the Roberti-Z'berg Urban Open Space and Recreation Program Act (SB 174) Fourth Year (FY 80).



BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$207,355 in Capital Outlay Funds from CIP No. 29-498 to CIP No. 29-410.

BE IT FURTHER RESOLVED, that the City Manager or his representative is hereby authorized to perform all necessary acts to secure the funds for these projects.
