WHEREAS, the City Council by Resolution No. 255593 amended the contract for furnishing employee group life insurance with Pacific Guardian Life Insurance Company, Ltd., by adding thereto, an Endorsement No. 3 to policy number GL 0370-000, issued to The City of San Diego; and

WHEREAS, said amendment was for a one-year period to expire October 20, 1982; and

WHEREAS, Pacific Guardian has guaranteed the current rate of \$.16 per \$1,000 of insurance coverage for an additional year and has provided said commitment via an attachment to Endorsement No. 3 to the existing contract; and

WHEREAS, premium rates payable by City employees for additional amounts of insurance will remain unchanged; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, an amendment to the contract with PACIFIC GUARDIAN LIFE INSURANCE COMPANY, LIMITED, consisting of an attachment to the existing Endorsement No. 3 to the basic policy of insurance, number GL 0370-000, for furnishing employees' group life insurance for a period of one year ending October 20, 1983, at an estimated cost

to the City of approximately \$257,400, under the terms and conditions set forth in the contract, as amended, on file in the office of the City Clerk as Document No. RR- 257413 .

BE IT FURTHER RESOLVED, that the expenditure in the sum of \$257,400 from Fund/Department 60026, Object Account 2302, is hereby authorized solely and exclusively for the purpose of providing funds for the above program.
