and the same are hereby approved.



BE IT FURTHER RESOLVED, that the expenditure of \$673,362.00 from Park Service District Fund 11220, CIP No. 23-501, MIRA MESA COMMUNITY PARK - Development, Phase II of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
