BE IT RESOLVED, by the Council of The City of San Diego as follows:


1. That it be, and it is hereby certified, that the information contained in ENVIRONMENTAL IMPACT REPORT NO. 80-07-22C, completed May 28, 1981, in connection with the State Coastal Conservancy for Crest Canyon Erosion Control Project, on file in the office of the City Clerk, has been completed in compliance with the California Environmental Quality Act of 1970, as amended, and the State guidelines thereto, and that said Report has been reviewed and considered by this Council.

2. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the State Coastal Conservancy, an agency of the State of California, for implementation of a project to control erosion in Crest Canyon and reduce the flow of sediment into San Dieguito Lagoon, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 257421 .

3. That the expenditure in the sum of \$343,800 from CIP 23-547.1, Crest Canyon Erosion Control Phase II; \$8,800 from Fund 30245, and \$335,000 from Fund 10505, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.


