WHEREAS, the Planning Commission of The City of San Diego has held concurrent public hearings to consider the Sabre Springs Community Plan to expand the Northridge Industrial area and amendment of the General Plan in order to retain consistency between said Plans; and

WHEREAS, on July 1, 1982, the Planning Commission approved and recommended for adoption by the City Council an amended General Plan; and

WHEREAS, California Government Code, Section 65869 provides that mandatory elements of the General Plan may not be amended more than three times per year; and

WHEREAS, it is the intention of the City Council to

consider amendments to the Progress Guide and General Plan for the City of San Diego at hearings conducted on a semi-annual basis; and

WHEREAS, it is the intention of the City Council to conduct a public hearing on proposed actions that will result in changes to the Progress Guide and General Plan during the year, but such changes shall not become effective until enacted at the semi-annual hearing conducted for the purpose of amending the Progress Guide and General Plan for the City of San Diego; and

WHEREAS, the Council of The City of San Diego held a public hearing to consider the amendment of the Sabre Springs Community Plan to expand the Northridge Industrial area; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That this Council hereby approves the amendment of the Sabre Springs Community Plan to expand the Northridge Industrial area, a copy of which is on file in the office of the City Clerk as Document No. RR-257427.
