
RESOLUTION NUMBER R- 257430

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to waive the \$65 per hour rental fee for the Allied Gardens Swimming Pool at the Allied Gardens Recreation Center the weekend of November 6 and 7, 1982 to enable the San Diego City Schools and the City Schools' Aquatic Booster Club to hold an Aquathon at this facility to raise money for their 1983 swim program, with the understanding that the Booster Club will either pay the \$17 per hour administrative fee or get the School District to provide staff and assume liability.
