RESOLUTION NUMBER R- 257461

Adopted on NOV 8 1982

WHEREAS, by Resolution No. R-255608 adopted on January 4, 1982, the City Council approved the formation of a Budgetary Reserve in the budget of San Diego Data Processing Corporation ("Corporation") for the purpose of modifying the Computer Center in the City Administration Building and the transfer of \$215,000 of the FY1980-81 surplus to said reserve, and approved an increase in the FY1981-82 budget to reflect the additional expense of \$215,000 for completion of the Computer Center modifications; and

WHEREAS, the City and Corporation have determined that the leasing and improving of a facility located at 5975 Santa Fe Street by Corporation would meet Corporation's needs for many years in the future and save in excess of \$1,800,000 over a projected ten-year period; and

WHEREAS, the leasing and improving of a facility located at 5975 Santa Fe Street by Corporation will render unnecessary the modification of the Computer Center in the City Administration Building; and

WHEREAS, there is presently \$180,795 remaining in the Budgetary Reserve established by Corporation pursuant to Resolution No. R-255608; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Council approves the use of the \$180,795

remaining in the Budgetary Reserve established by Corporation pursuant to Resolution No. 255608 for like improvements to the facility located at 5975 Santa Fe Street in the City of San Diego.

BE IT FURTHER RESOLVED, that the City Council approves the transfer to said Budgetary Reserve of \$371,561 from the FY1981-82 surplus of Corporation to use for improvements to said facility.

BE IT FURTHER RESOLVED, that the current FY1982-83 budget be increased by \$600,000 to reflect the additional expense for facility improvements and relocation.
