RESOLUTION NUMBER R- 257463

Adopted on NOV 8 1982

WHEREAS, on November 30, 1981, the City Council of The City of San Diego (the "City") adopted Resolution No. R-255428 (the "Resolution") approving and authorizing the issuance of bonds to acquire and finance facilities described in the Application dated November 19, 1981, submitted by the National Steel and Shipbuilding Company (the "Participating Party"); and

WHEREAS, the Participating Party has submitted an Amended Application dated September 29, 1982, amending the location and description of the facilities to be financed and eliminating the building acquisition in connection with the original facilities; and

WHEREAS, the City desires to continue to assist the Participating Party in the financing of the new facilities pursuant to the Resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Resolution be amended as follows:

Section 1. Any and all references in the Resolution (including Exhibit A thereto) to the Participating Party's Application shall be deemed references to such Application as amended and supplemented by the Amended Application dated September 29, 1982.

Section 2. Any and all references in the Resolution to the facilities as described in Exhibit A shall be deemed references to the facilities described in the Participating

Party's Amended Application dated September 29, 1982.

Section 3. Any and all references to the acquisition of a building in connection with the facilities shall be stricken in accordance with the Participating Party's Amended Application dated September 29, 1982.
