WHEREAS, it is The City of San Diego's intention to achieve certification of its Local Coastal Program (LCP) by the California Coastal Commission; and

WHEREAS, a Local Coastal Program includes land use plans, zoning and other related implementing ordinances, and zoning district maps; and

WHEREAS, there should be consistency between the implementing ordinances, zoning district maps and the Coastal Zone segment land use plans; and

WHEREAS, the Planning Commission, on May 13, 1982, and June 10, 1982, conducted public hearings, adopted, and recommended approval of the Barrio Logan/Harbor 101 Segment Land Use Plan, its implementing ordinances, and the proposed rezoning actions; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the amendments to the Barrio Logan/Harbor 101 Segment Land Use Plan, Attachment 9 to Planning Report No. 82-258, its proposed implementing ordinances, and the proposed rezoning actions, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the City Council hereby authorizes the resubmission of the Barrio Logan/Harbor 101 Segment Land Use Plan as herein amended and its proposed implementing ordinances to the California Coastal Commission.

BE IT FURTHER RESOLVED, that the Planning Department is

authorized and directed to initiate rezonings as indicated in
the proposed implementing ordinances following final and
effective certification of The City of San Diego's Local Coastal
Program by the California Coastal Commission.
