
BE IT RESOLVED, by the Council of The City of San Diego as follows:

BE IT FURTHER RESOLVED, that the expenditure in the sum of \$10,000 from Community Development Block Grant (CDBG) funds, commencing November 1, 1982 and terminating March 31, 1983, is hereby authorized, solely and exclusively for the purpose of providing funds for the above program.

BE IT FURTHER RESOLVED, that the transfer of \$10,000 from Fund 18518, Dept. 5619, Org. 1901 (Contingencies) to Fund 18518, Dept. 5614, Org. 1407 ("Mainstream Magazine" Project) is hereby authorized.
