BE IT FURTHER RESOLVED, that the expenditure of \$104,000.00 from Park Service District Funds, CIP No. 23-549, POINT LOMA COMMUNITY PARK - Additional Improvements, of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
